Radio Rancho, LLC, its subsidiaries (together, “THE COMPANY”), will conduct the Contest substantially as described in these rules, and by participating, each participant agrees as follows:

1. Description of Contest / Participation

A. Dates of Contest:

The contest will begin on Monday, January 31st and will end on Friday, March 4th 2022.

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of participants.

B. How to enter:

Contestants will be qualified by one or more of the following methods:

- 1) Listeners will go to [www.facebook.com /lapoderosa1007fm](http://www.facebook.com/lapoderosa1007fm) and www.facebook.com/lagrand1063. Our on-air host will be announcing on-air for a chance to win, they will need to call the studio to register at 7:20, 8:20 and 9:20 during the Morning Show, Mon-Friday.
- 2) Listeners can also visit our Social Media Pages, and send a DM with their full name, phone number and city/state. Contestant must meet all eligibility requirements and comply with all rules to qualify for the prize.

C. How Winner is Chosen:

Ivan from Idaho Central Credit Union, main sponsor will come weekly and select 3 winners per station on Friday, during a Facebook Live with our On-air host. ALL DECISIONS MADE BY JUDGES ARE FINAL.

2. Prize(s). The prize that may be awarded to the eligible winner for each category is:

- A. Monday - \$100 ICCU Visa Card
- B. Wednesday - \$100 ICCU Visa Card
- C. Friday - \$100 ICCU Visa Card

Total estimated prize value, including the cash for El Gana Gana & Recuperate: \$3,000

3. Eligibility and Limitations.

Participants, contestants and winner(s) must not have won within the last 30 days, must be U.S. residents of Idaho, and within the 65-mile radius of Nampa, at least 18-years old as determined by the Company, have an active social security number, and be able to present the original social security card and Idaho ID to contest officials before the prize is awarded. If a selected contestant is a minor under 18 years of age, responsibility and eligibility will default to parent or legal guardian. A parent or guardian of any participant who is a minor must sign a release on behalf of the minor to be eligible to receive a prize, and that parent or guardian will assume all responsibilities and eligibility requirements as outlined in the contest rules. The Company reserves the right to refuse to award a prize to or on behalf of any minor.

Only one (1) qualifying contestant per household for the Contest. Employees of the Company, the Contest's participating sponsors and their advertising agencies, employees of other radio or television stations, existing employees at Brightwood College, and members of the immediate family of any such persons are not eligible to participate and win. Regarding eligibility, the term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

4. Taxes.

Any valuation of the prize(s) stated above is based on available information provided to the Company, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes. Each winner must provide the Company with valid identification and a valid taxpayer identification number or social security number before any prize will be awarded. Any person winning over \$600 in prizes from a station will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS. By participating, all participants and winner(s) grant the Company exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion of this and other contests and waive any claims to royalty, right, or remuneration for such use. By participating in the Contest, participants agree that the Company may disclose personal information obtained from participants in the Contest to third parties and use such information for marketing and other purposes.

6. Affidavit. Winners may be required to sign and return an Affidavit of Eligibility and Release of Publicity and Liability within 14 days of notification of winning. Failure to sign and return the affidavit and release within such period or to comply with any term or condition of these Official Rules may result in disqualification and forfeiture of any interest in a prize.

7. Release.

By participating, each participant and winner waives any and all claims of liability against the Company, its employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize. In order to receive a prize, participants must sign an official waiver form provided by the Company. The company assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of entries. The company is not responsible for any problems or technical malfunction of any telephone network or lines, computer on-line-systems, servers or providers, computer equipment, software, failure of email, technical problems or traffic congestion on the Internet or at any website or combination thereof, including injury or damage to participants or to any person's computer or data related to or resulting from participating or downloading materials in this Web site or Contest. The company is not responsible for cheating or fraud by any entrants. Any activities intended to disrupt or interfere with the proper play of the Contest, or to defraud the Sponsor in any way, may be prosecuted to the fullest extent of the law. Participants engaging in any of the foregoing activities will be disqualified and will forfeit any prizes won. If, for any reason, the Contest is not capable of operating as planned, including, without limitation, as a result of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the reasonable control of the company which corrupt or affect the administration, security, fairness,

integrity or proper conduct of this Contest, the company reserves the right at their sole discretion to cancel, terminate, modify or suspend the Contest and award prizes among eligible entries received.

8. Decisions.

By participating in the Contest, participants agree to be bound by the decisions of Company personnel. The Company reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or who the Company believes has violated any rule, gained unfair advantage in participating in the Contest, or obtained winner status using fraudulent means. The Company will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Company's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Company, the Company reserves the right to terminate this Contest, or make such other decisions regarding the outcome as the Company deems appropriate. All decisions will be made by the Company and are final. The Company may waive any of these rules in its sole discretion.
